- Development for future needs beyond 2020 for up to 2000 people





### Need for a sustainable development with focus on mobility

Construction needs and VSS require a reduction of parking space, while the parking was full every day and 73% of the population was driving in by car.






- In 2011 we had a ratio of 1 : 1.8 parking slots to employees
- Hiring has driven this to 1 : 2.2 in 2013
- Temporary constraints due to construction is driving this to 1: 3.2 in 2016
- After construction we will end up with VSS driven 1 : 3 ratio

Significant modal transfer required

Given the magnitude of change (transfer modal) required we hired a consultancy and selected a participative approach with he employees

# Waves of Emotion Ideology – Freedom – Ecology **Justice** Everybody is an expert



Behavior change takes time!

#### Works well:

- Safe conditions on site
- Covoiturage
- **Occasional Parking**
- Fairpark platform
- 2 wheelers (parking, lockers, showers, rebate)
- Visitor's parking

Mobilis rebate

### Does not work well:

- Long waiting list for individual parkings
- Wild Parking around the site while utilization of P+R still low
- Not enough modal true transfer
- Some users are gaming the system
- Increased administrative effort

### Would do differently:

- Take more time for the whole process (i.e.: start earlier)
- Engage authorities earlier in the process.
- Make a stronger use of monetary incentives to drive behavior vs. detailed rules
